We know this might be new to many of you, but International students must also file taxes.

As a non-resident in the US, you're legally required to file a tax return if you received US income or just attended school during **2023** by the **April 15, 2024** deadline.

And even if you didn't work or receive income in the US last year, you're still obliged to file a Form 8843 with the IRS.

One with the information of the webinars that **Sprintax** is hosting to explain everything you need to know. When you finally secure a job on campus for the first time, as an international student you will need to apply for a **Social Security Number (SSN)** to finish your hiring process and start working. Detailed instructions for the SSN application are in the learning content.

You will submit this request uploading your immigration documents (Visa, Passport, I-94 and Signed "Continued Attendance I-20") IPO can verify and communicate your eligibility to UT's Human Resources Office. They will issue the letter that you need to take to the Social Security Administration Office to submit your application in person. The process may take around 2-3 weeks

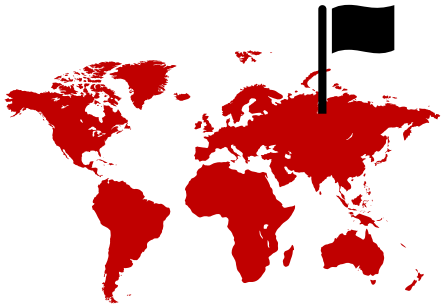

Did you know that one of the immigration requirements to register your continued attendance to school in SEVIS every semester is to **maintain a foreign address and phone number**?

Sometimes you will feel so comfortable here, and maybe add a different address in Workday for receiving your mail, or diploma, or your bills. Be careful not to overwrite your home country address, and always maintain it tagged as **international permanent**.

Do the same with your foreign phone number, if you no longer use it, you can then provide there the phone number of your emergency contact back home.

In our website (internationalservices.ut.edu) we have instructions on how to correctly update your contact information in Workday.
