Taxes Filing Season 2023 is close to the end

Every international student who was in the US during 2023 must file taxes.

Even if you did not receive any income or worked, you are obliged by law to file taxes to the IRS before **04/15/2024**.



Prepare and file your US tax return easily online with Sprintax

Since International Student Advisors are not authorized nor qualified to provide any tax related advised, the University of Tampa has arranged that **Sprintax** takes care of this for you. Just create your account, provide all your information and let **Sprintax** generate the forms and documents you need to sign and submit to the IRS. It will be at no cost or a reduced fee for you if you use the University code we have sent to your email.

Any questions about this process should be address to **Sprintax** in their 24/7 help chat available in their website once you create your account.

When your International Student Advisor reviews your request and finds anything that needs to be changed, you will receive an email listing what needs to be corrected, or notifying that you have a message in your ISSS portal profile with that list.

In that case, you don't need to start a new request, but click on the one you already submitted. It is under the **Ongoing Requests** section, in **Clarification Requested** status. Starting a new one will most of the times place it in **Approver Review** status, and most likely it will be dismissed, since your Approver already processed it. Therefore, it will never reach your International Student Advisor for review.

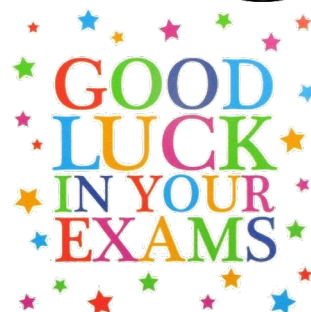
